RESOLUTION OF THE WINSTON-SALEM/FORSYTH COUNTY BOARD OF EDUCATION FOR ENVIRONMENTAL SUSTAINABILITY

WHEREAS, the Winston-Salem/Forsyth County Board of Education holds these core values; that we are student-centered, hold ourselves accountable, believe in collaboration, strive for equity, hold high expectations for students and staff, and act with integrity; and we commit to including environmental sustainability into the decisions we make around operations and the curriculum.

WHEREAS, we are student-centered, we believe in authentic student engagement, and will work with them towards creating a sustainable world now and into their future;

WHEREAS, we hold ourselves accountable to make decisions around sustainability that will include operations, curriculum, policy, and programs in measurable ways;

WHEREAS, because we believe in collaboration, we encourage educators, students, and stakeholders to work together to expand and grow from each other. We are grateful that our Forsyth County Board of Commissioners adopted a resolution in 2019 committing to using clean, renewable energy with a goal of transitioning to 100% clean and renewable energy by 2050. We believe that our schools should practice conservation of resources, limit waste in landfills and be built and renovated to be as energy efficient as possible;

- Establishing demonstration schools to showcase possibilities and finding existing structures (i.e. Forest Forsyth) with which to partner and build upon.
- Engaging authentically with students through participation in waste reduction, planning and planting new growth, and other possibilities yet unknown.
