The 2020 Environmental Issues Candidate Survey was developed to solicit and aggregate local candidates' plans and priorities for a more resilient, just, and environmentally sustainable North Carolina. We created this survey to share where candidates stand on key environmental issues and mobilize voters in Forsyth and Guilford Counties to vote.

The survey was distributed to all candidates on the ballot in Forsyth and Guilford Counties running for: Mayor, City Council, County Commissioner, NC State House of Representatives, and NC State Senate. The survey questions were formed around six main environmental issue categories:

### CLIMATE CHANGE RENEWABLE ENERGY TRANSPORTATION AND THE BUILT ENVIRONMENT CLEAN WATER PUBLIC GREEN SPACES ENVIRONMENTAL JUSTICE

Now more than ever, we need strong leadership to address the crises we face - from COVID-19 to climate change. This leadership must begin at the local level.


"I am proposing the county stand up an Environmental Council [to] develop environmental policy and organizational recommendations proposals to the County Commissioners. I want to ensure the county achieves it's net-zero emissions goals. Further, I would like the county to improve its air quality and bring solar solutions to county owned rooftops and land."

"I believe we need to prioritize, promote and improve current policies. For example, the county commission proactively created a great solar policy, but hasn't taken on any initiatives to attract or explore solar solutions. They were proactive in setting goals for making the county 100% reliant on clean and renewable energy sources by 2050, but [did not] commit to 2030 goals and have taken no steps to move in that direction since then. The county also has grant funding available for environmental initiatives through the Soil & Water Conservation Department, but they are not advertised and subject to defunding. My proposed Environmental Council would help spearhead new initiatives and proposals on behalf of the county."

"A great number of policies are already in place. Utilizing new technologies should be at the top of the list for the remainder of the 21st-century. The county should absolutely implement a better public transportation infrastructure. We need to better connect our county with more efficient routes and more bus stops. The busses running those routes need to be carbon neutral. Retroactively adding biking and pedestrian infrastructure offers a more challenging hurdle in our cities and towns but should absolutely be a part of any future planning. Our county has quickly risen as a favorite spot in the bicycling community and we need to be supporting and embracing this community."

"The county has an integral role in protecting our water systems. In Forsyth, we are specifically dealing with aging infrastructure. The county must continue in its effort to upgrade water treatment facilities, stormwater management systems, and wastewater systems. This issue has unfortunately been neglected by federal and state legislators, putting the burden on local officials to solve the problem. We must also be vigilant in protecting our watersheds, rivers, lakes, and streams. We should be more proactive in exploring innovative ways to address these environmental needs."

For example, when Winston-Salem is discussing the beautification project in East Winston, or planning for new affordable housing developments, the county needs to coordinate to ensure we have the appropriate infrastructure resources available to support these endeavors and furthermore, we must be prepared to assist with issues such as zoning, to accommodate these projects."



"Housing and transportation are my areas of interest. In brief, public transportation requires density to operate with the reliability and frequency that makes it an attractive option. This density is illegal in the county due to zoning laws and reinforced through NIMBY opposition. By promoting missing middle housing, enacting zoning reform, and reallocating money from car infrastructure to bikes and walking we can create a just and sustainable transportation system in the county."

The county should pay reparations for the environmental injustices and harms on the local communities of color."

### **AMBER BAKER (D): DISTRICT 72**

"I support Governor Cooper executive order 80 with the 2025 goals of reducing statewide greenhouse gas emissions to 40% below 2005 levels, increasing the number of registered, zero-emission vehicles (ZEVs) to at least 80,000 and reducing energy consumption per

square foot in state-owned buildings by at least 40% from fiscal year 2002-2003 levels. I also support the recommendations from The North Carolina Climate Risk Assessment and Resilience Plan which is NC's first climate change adaptation plan. It includes recommendations for nature-based solutions to enhance ecosystem resiliency and sequester carbon in the state's natural and working lands."

"Restore and strengthen clean water policies, including wetlands protection, CAFO regulation, riparian buffers, and regulation of emerging pollutants including PFAS. Aggressively pursue transition to clean energy sources (including solar, wind, and utility-scale energy storage),

and away from fossil fuel and nuclear sources. This will require stepped-up REPS, development rules encouraging wind generation (including offshore wind), favorable solar energy purchasing rates, and encouraging broad development of home and community-scale solar systems (e.g. through net metering and thirdparty financing). This is a key part of our strategy to address climate change."

"Ratchet up the Renewable Energy Portfolio Standard to require that a steadily increased share of our electric generation come from renewable sources like solar and wind. Restore and expand tax incentives for renewable energy development and use—at the production level and for commercial and residential end users. Enable third-party sales contracting to encourage development of small community non-profit solar systems. Guarantee fair reverse-metering rates that encourage solar and wind development. Create incentives for development and deployment of advanced battery energy storage at the utility, commercial, and residential levels. Actively encourage the development of environmentally sound offshore wind resources."

"Build out the network of publicly accessible electric vehicle charging stations. Incentivize the transition of public vehicle fleets to electric. Follow through on "complete streets" policies for NCDOT-funded projects, with an emphasis on community connectivity. Streamline the permitting and funding processes for active transportation projects, including appropriate engineering design flexibility for greenways and bike paths. Increase funding dedicated to active transportation, public transit, and rail. Remove the current disincentives for passenger rail system development. Instead, require consideration of fixed-rail and BRT systems as alternatives or supplements to proposed new highway development. Require that bike/ped access be routinely included when bridges, overpasses, and underpasses are replaced or expanded across other highways and other barriers."

"Restore protections for wetlands and riparian buffers, and allow local governments to add stronger local requirements. Maintain and strengthen stormwater quality and quantity management programs. Implement comprehensive testing and monitoring programs for emerging pollutant threats such as PFAS. Restore and strengthen the scientific and regulatory staff capacity of DEQ."

"Restore and expand funding for the CWMTF, Parks & Recreation, and farmland preservation funds. Utilize tax incentives for private land conservation efforts."
