The 2020 Environmental Issues Candidate Survey was developed to solicit and aggregate local candidates' plans and priorities for a more resilient, just, and environmentally sustainable North Carolina. We created this survey to share where candidates stand on key environmental issues and mobilize voters in Forsyth and Guilford Counties to vote.

The survey was distributed to all candidates on the ballot in Forsyth and Guilford Counties running for: Mayor, City Council, County Commissioner, NC State House of Representatives, and NC State Senate. The survey questions were formed around six main environmental issue categories:

CLIMATE CHANGE RENEWABLE ENERGY TRANSPORTATION AND THE BUILT ENVIRONMENT CLEAN WATER PUBLIC GREEN SPACES ENVIRONMENTAL JUSTICE

Now more than ever, we need strong leadership to address the crises we face - from COVID-19 to climate change. This leadership must begin at the local level.

CARLY COOKE (D): DISTRICT 5



How important is it for the county to take actions and adopt policies that mitigate the impacts of climate change? What specific goals and measures should the county adopt to mitigate the impacts of climate change?

"With deregulation at the federal level, it is more important than ever to focus on environmental protections in our local community. One way we can do that is to incentivize development in underutilized or vacant areas within our urban footprint, which puts

people and jobs in closer proximity thereby reducing carbon emissions from travel while preserving green space in our rural areas. We should also continue to invest in and prioritize our parks, greenways, and bike trails to enable Guilford County citizens to bike and walk around our community safely. Additionally, as we look at the need to rebuild or renovate many of our school buildings, we have the opportunity to explore sustainable building practices and renewable energy sources with a goal of net zero carbon footprint for these new or updated schools. The county also has the option to retrofit many of the existing buildings with energy efficient systems that would offer a secondary benefit of immediate savings on energy costs. Lastly, I would like to see the county form a sustainability council comprised of Guilford County citizens who are invited to participate in shaping our plan for the local environment."

How important is it for the county to reduce reliance on fossil fuels and shift to renewable energy resources? What policies and programs should the county use to shift the state to a cleaner energy mix for all residents?



"It seems there is an opportunity to explore renewable energy and make updates to our energy infrastructure by attracting the development of these new clean energy companies in our community. Renewable energy sources used to be cost prohibitive but that has changed so subsidies are not always required to make it feasible. I look forward to having conversations about this with experts and community stakeholders once in office to explore what our options are in Guilford County that will contribute to a cleaner North Carolina."

"City design and urban planning is mostly left to the municipalities, but the county can support those entities in their efforts to increase public transit options and to continue to invest in pedestrian and bicycle paths on county parks and greenways. We can also prioritize development in unused areas within our urban footprint to reduce travel time for those who can live and work in the same area."

How important is it for the county to protect and regulate local water quality? What measures can the county take to protect our local public water?

"Clean water is vitally important for a healthy community. Guilford County should coordinate with our cities and the state of North Carolina to advocate for research on emerging compounds and chemicals in our water sources. We must prioritize the sharing of information and research with our cities, neighboring counties, and the state and encourage our state partners to fully fund the work being done by the NC Department of Environmental Quality to ensure that they can continue their important scientific research that is necessary to keep us all safe. Specifically in Guilford County, we need to address the issue of lead in the drinking water at our many public school buildings. This is a symptom of the bigger problem deteriorating, poorly maintained facilities - that could have very serious consequences for our children's health."

"Climate change is a scary reality and we must be vigilant in addressing it directly at the local level. I would like to see local incentives offered to both commercial and residential properties for transitioning to solar energy. Clean energy is our primary hope for a

solution to climate change, and at the local level we need to leverage our purchasing power and our investment in new facilities by building green-certified structures, and committing to green power as the primary energy source for government-owned facilities and vehicles. Additionally, we need to clean up existing hazardous waste, hold corporations and individuals responsible for proper disposal of their hazardous waste, and clean-up abandoned sites, ensuring economic development and sustainability on those sites. A final important strategy involves the agricultural sector. Small family farms need systemic support so that they can grow our food sustainably and adhere to land use strategies that improve. rather than deplete, soil health. Such support will lead to a decrease in greenhouse emissions, thereby reducing the impacts of climate change."

"It is very important to take intentional steps to reduce our reliance on fossil fuels and shift towards renewable energy resources. Some ways we can do this include investing in low emissions (hybrid or electric when possible) vehicles for our fleets, and exploring solar energy initiatives and grants to provide clean energy and cut energy costs in our schools and county facilities. Greensboro City Council established a Community Sustainability Council (CSS) of 9 Greensboro residents based on their knowledge and experience with sustainable resources. This is common across the country. One member is selected for each of the 5 city districts and they meet once a month. The county should partner with the council or create their own sustainability council."

Very Important "According to Guilford County Transportation and Mobility Services, there are options available for residents who live outside of the city limits of Greensboro and High Point. However, after conversations with affected residents, it is clear that there is room to grow. Expanded public transit options positively contribute to economic development and need to be prioritized. With regard to city design, infrastructure that is pedestrian and bike friendly is not only beneficial to those who use these transportation options, but is also environmentally responsible."

"Some measures the county can take to protect our local public water include: regular monitoring for changes that identify degradation of water bodies, preserving existing vegetated buffers around bodies of water to prevent the flow of contaminants into surface water, and provide incentives to developers to limit disturbance and tree removal during new building/development processes. Another tool would be to incentivize LID (low impact development) in future development contracts. NC House Representatives Clemmons and Harrison have both worked to protect Guilford County water at the state level, and it is the role of the local government to be supportive of these efforts."

"Greenways provide an aesthetic appeal popular among community members and businesses alike. Greenways provide easy and safe access to public transportation, provide plants and trees that positively impact the local environment, and stormwater landscaping diverts millions of gallons of rainwater every year. Greenways also support local artists by including murals and sculptures to celebrate the diversity of Guilford County. "In the wake of the pandemic, our greenways have seen a dramatic increase in usage." - Greensboro Greenway Project Manager Dabney Sanders. There is an opportunity for Guilford County to expand upon this strong foundation and continue the efforts beyond downtown Greensboro and across our community."

"A bold first step would be to declare racism a public health crisis. More than 80 cities, counties, and states across the nation have already done so. We could make Guilford County the second county in NC to do this. Mecklenburg County made their declaration on June 16th and the Charlotte Mayor signed a proclamation on June 17th. A declaration could put the spotlight on environmental racism and encourage greater urgency to address the systematic problems. We can also require racial bias training for all county employees. Additionally Guilford County should continue to partner with the Weatherization Assistance Program and consider how we might make permanent a COVID-19 response program that is currently offering temporary assistance to citizens who can't pay their water bills during this crisis."

"North Carolina is one of the most beautiful states on the east coast. Our lands are so diverse and our government has taken many steps to preserve our lands. Time after time we have seen folks trying to use our land for their profit. If we don't continue to protect and expand protected areas we will fall victim to crony capitalism and it's always an abuse of environmental stewardship."

"These communities are the first to be exploited when big corporations come into town. They will offer low paying jobs with little to no benefits all while polluting neighbors they believe to be "forgotten" by lawmakers. We see this all over the country. These communities need new, green, union jobs with \$15+ minimum wages and benefits to replace the factories that shut down long ago. These communities have been displaced for too long."

How important is it for the State of North Carolina to take actions and adopt policies that mitigate the impacts of climate change? What specific goals and measures should the State of North Carolina adopt to mitigate the impacts of climate change?



"The most recent IPCC report advises that we must limit temperature rise to 1.5 degrees Celsius to avoid irreversible catastrophic climate change. Acting swiftly to address climate change has long been a priority of

mine. NC is particularly vulnerable to climate change, especially our high risk coast. We should adopt a standard for zero carbon emissions by 2050, with substantial progress toward that goal in the next 10 years (legislation which I have sponsored). I co-chaired the Legislative Commission on Global Climate Change which made a number of recommendations on this subject more than 10 years ago. Over my 16 years in office, I have sponsored legislation proposing our Renewable Energy Standard, greater building efficiency, energy savings, renewable energy investments, green schools, and more. We must eliminate our dependence on fossil fuels; mandate a cleaner transportation sector; require more efficient buildings;

eliminate any barriers to renewable energy systems (eg the wind moratorium) while maintaining necessary protections; put in place better agricultural practices; provide more incentives and invest in land conservation; and anything else we can do to shrink our carbon footprint.

At the federal level, the US officially withdraws from the Paris climate accord on November 4, 2020; we must do what we can to stop that."

How important is it for the State of North Carolina to reduce reliance on fossil fuels and shift to renewable energy resources? What policies and programs should the State of North Carolina use to shift the state to a cleaner energy mix for all residents?



"What policies and programs should the State of North Carolina use to shift the state to a cleaner energy mix for all residents? As stated above, we must eliminate our use of fossil fuels, as well as restore our ban on fracking and offshore drilling. We face a zero carbon future and fossil fuel based energy sources will be obsolete. We should adopt a higher REPS goal similar to California and Hawaii. We should increase the energy efficiency of any buildings using public funds. We should reinstate tax credits for renewable energy investments. We should invest in cleaner transportation infrastructure. We should invest in battery storage technology. And more."

How important is it for the General Assembly to pass legislation that transforms the transportation sector? What policies and programs do you support to transform the transportation sector and provide active and public transportation options for people across the state?



"Transportation is a large source of greenhouse gas emissions and we must do what we can to move to a cleaner transportation sector. Increasing funding for public transit including our trains (which have suffered many cuts over the last decade) and other forms of alternative transportation, including bike paths and greenways, is a good start. We are likely facing a transportation sector that will be dominated by electric vehicles. That will necessitate charging stations, improved battery technology, and more. That will also mean devising a new system for funding our highways, which is currently largely dependent on proceeds from the gas tax. CAFE standards are established at the federal level and the Obama era CAFE standards and CA clean cars standard must be restored. I had advocated for NC to adopt California's clean car standard for years, but could never get traction for that, and I will continue to push for that."

How important is it for the NC General Assembly to pass legislation that protects and regulates water quality? What policies and programs do you support to protect and regulate public water sources in North Carolina?



"The recent US News and World Report state rankings on the Natural Environment places NC 42nd on air and water quality, due to bad air quality days and issues with water quality. We have seen a number of rollbacks of important state measures protecting the quality of our air and water, including storm water controls and buffers. NC faces a public health crisis with emerging contaminants including PFAS which is poisoning North Carolinians. We must restore those air and water quality protections that have been rolled back or repealed in the last decade. We must repeal the Hardison amendments which handcuff our state agencies as well as any other obstacles to protecting the public health that have been put in place in the last decade. In a perfect world, we would adopt the precautionary principle as the EU has done, which would mean nothing would be allowed to be emitted or discharged unless it could be proven to be safe. And we must adequately fund the state agencies (DHHS and DEQ) who are charged with protecting the public's health."

"Open spaces are important for one's quality of life, especially mental and physical health. They also play a role in mitigating climate change. It is much less expensive to acquire undisturbed land that restore it. The NCGA should reinstate the conservation tax credit that helped provide incentives to land donations and contributions to land donations. We should restore the dedicated funding sources that had been used to fund the Natural Heritage Trust program, the Parks and Recreation Trust Fund, and other similar programs. Once our budget is sounder, we should continue to prioritize funding the Clean Water Management Trust Fund and other conservation programs. I was glad to see that Gov. Cooper's currently proposed budget includes \$20 million in federal CARES Act funds to address needs at NC's state parks and trails."

There is much that must be done systematically to undo that damage. Low income communities and communities of color are most vulnerable to environmental injustice, and are most likely to be located near toxic polluters and areas particularly vulnerable to climate hazards. Environmental justice and cumulative impacts should be factors in permitting decisions. The state should invest more in black, immigrant, indigenous, and community of color, including access to health care, better educational opportunities, sustainable jobs, a fairer criminal justice system, fairer elections, police accountability, safe and affordable housing, etc. Until we address racial injustice, we cannot adequately deal with environmental injustice. Acknowledging and addressing systemic racism is critical if we are going to achieve environmental and climate justice. One specific example is to restore clean air protections. Since the onset of the pandemic, many are acknowledging the environmental and health inequalities in our current system. People of color are getting sick and dying from COVID at a disproportionate rate. We know that communities of color are subject to more air pollution and poor air quality is tied to respiratory and cardiovascular health. When people of color suffer at such a higher rate from asthma and other respiratory and cardiovascular diseases, we

MUST respond. Legislation ensuring communities of color have clean air is critical






